Therapy Services

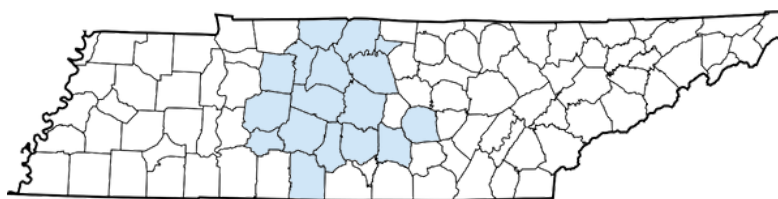
On-site pediatric therapy, individualized treatment plans, and collaboration with teachers ensure children get the help they need right where they are.

This year, **1,083 children** from **17 counties** walked through our doors—each with their own dreams, challenges, and potential.



In our therapy clinic, **990 children** received **35,595 sessions** of specialized support, helping little ones take first steps, find their voices, and reach new milestones.

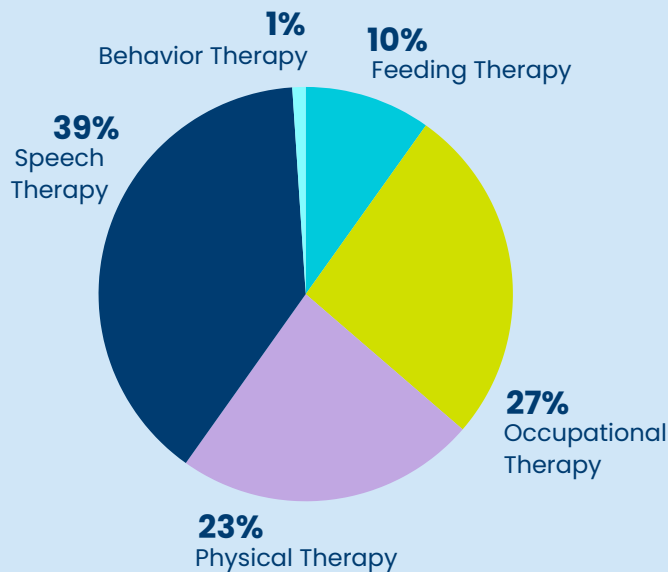
In our inclusive preschool, **93 students** experienced **109,200 hours** of play-based learning where every child belongs, learns, and shines.

Guided by a dedicated team of **20 teachers** and **34 therapists**, we work together each day to build brighter futures—one child, one milestone, one moment at a time.

Because of your support, families never have to choose between education and therapy—they can find both, under one roof.

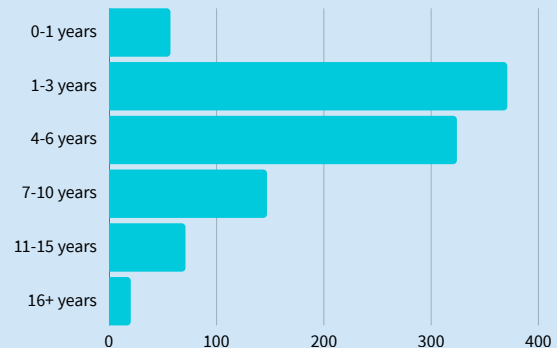
Therapy Clinic Highlights

The children served in our therapy clinic have a wide variety of diagnoses. The top five documented diagnoses supported account for 58% of the patients served.

- 7% Cerebral Palsy**



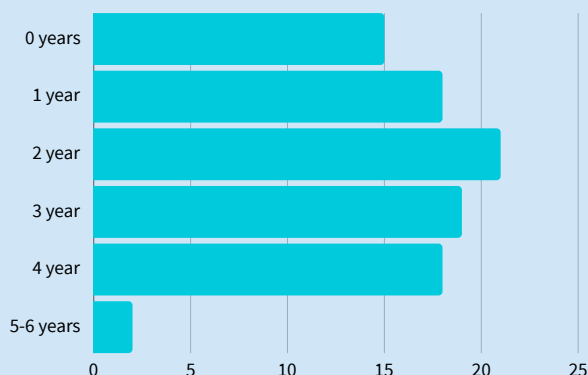
100% of parents agree or strongly agree that High Hopes therapy services have made a difference in their child's life and their ability to care for/support their needs.

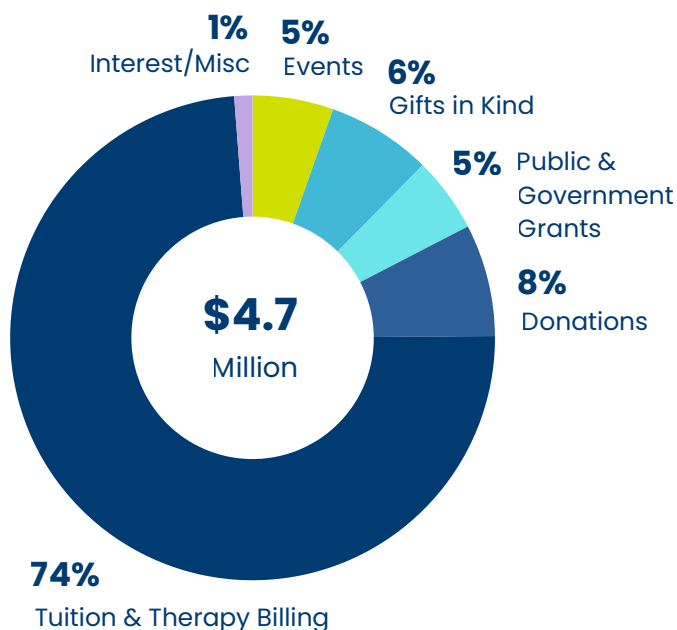
